

M/WBE Summary

Bid documents were distributed to 18 general contractors. Bids were opened on October 21, 2010. SJ Louis Construction of Texas submitted the lowest bid of 5 bids received. The bid includes an allowance of \$10,000 for support to public outreach activities during construction, including media and executive site visits. The total bid amounts, including the \$10,000 of allowance are:
