ORDINANCE NO.

1 **AN ORDINANCE AUTHORIZING AN ADVANCE FUNDING AGREEMENT**
2 **WITH THE TEXAS DEPARTMENT OF TRANSPORTATION, ACCEPTING**
3 **GRANT FUNDS, AND AMENDING THE FISCAL YEAR 2010-2011 AUSTIN**
4 **PUBLIC WORKS DEPARTMENT SPECIAL REVENUE FUND (ORDINANCE**
5 **NO. 20100913-002) AND CAPITAL BUDGET (ORDINANCE NO. 20100913-003)**
6 **TO TRANSFER AND APPROPRIATE GRANT FUNDS.**

8 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

10 **PART 1.** The Council authorizes the execution of an Advance Funding Agreement with
11 the Texas Department of Transportation for award of \$353,583 in federal funds to
12 construct sidewalks near various city schools as well as conduct a city-wide safe
13 bicycling and walking campaign.

14 **PART 2.** The Council authorizes the acceptance of \$353,583 in grant funds from the
15 Texas Department of Transportation to construct sidewalks near various city schools as
16 well as conduct a city-wide safe bicycling and walking campaign.

17 **PART 3.** The Council amends the Fiscal Year 2010-2011 Public Works Department
18 Operating Budget Special Revenue Fund (Ordinance No. 20100913-002) to appropriate
19 \$353,583 in grant funds.

20 **PART 4.** The Council amends the Fiscal Year 2010-2011 Public Works Department
21 Capital Budget (Ordinance No. 20100913-003) to transfer in and appropriate \$353,583
22 from the Public Works Department Operating Budget Special Revenue Fund (Ordinance
23 No. 20100913-002).

24 **PART 5.** The Council amends the Public Works Department Child Safety Fund
25 Operating Budget (Ordinance No. 20100913-002) to transfer in and appropriate \$180,524
26 to the Public Works Department Capital Budget (Ordinance No. 20100913-003) for a
27 portion of the City's match for funding to construct sidewalks near various city schools as
28 well as conduct a city-wide safe bicycling and walking campaign.
