SUSTAINABLE FOOD POLICY BOARD MINUTES

David Salazar, from Travis County Health Department, announced the reappointments of Katie Kramer and Michele Murphy-Smith. New appointed board members are Paige Hill and Erin Flynn. The County is reviewing the applications and resumes for the one vacancy left.

B. Update on Sustainable Food Policy Board recommendations to council on farmers market permitting fees and staff response (Paula McDermott)

Members Ronda Rutledge and Paige Hill recused themselves from Item 3B. Chair Paula McDermott gave an update of the PHHS meeting and will bring further updates in April 7, 2011 City Council meeting. No action taken.

C. Update on the Austin Climate Protection Program (Arthur D'Andrea)

Member Arthur D'Andrea attended the March 25, 2011 meeting and gave a brief update. The objective of the program is to encourage local food production and urban farms with land and water distribution and land use policies during and after extreme weather conditions. Arthur will continue to attend meetings, which are currently on a quarterly basis, and will keep board posted with updates. No action taken.

D. Proposal to produce annual report of the Sustainable Food Policy Board each April (Allison Beadle and Marla Camp)

Members Allison Beadle and Marla Camp are working on the annual report and to present at April's meeting.

E. Change of meeting dates in December of 2011.

Board approved to have the Executive Committee meeting changed to December 12, 2011 and the full Board meeting changed to December 19, 2011 due to the City of Austin office closed on December 26, 2011. Vote of 11-0.

F. Establishment of initial Sustainable Food Policy Board Working Groups (Paula McDermott)

After some discussion, the Board voted on the following:

Imagine Austin (led by Michele Murphy Smith)

- Purpose: To review the Imagine Austin process and current plans, to invite participation
 and ensure representation in each of the 7 work groups. Participants are expected to
 voice the importance of sustainable local agriculture and of access to healthy food for
 Austin residents across all income and geographical areas as it specifically relates to
 each comprehensive plan working group. The targeted outcome is high priority foodrelated objectives on the final working plan for each group.
- Timeline: April to end of summer (August) 2011 report to SFPB bi-monthly and assess for outcomes (and any recommendations for action by SFPB or City Council) in August.

Board unanimously agrees to accept Imagine Austin working group. Vote 11-0.

Supplemental Nutritional Assistance Program (SNAP) Participation (led by Arthur D'Andrea)

- Purpose: To collect, compile and report all information relevant to Supplemental Nutrition Assistance Program (SNAP) participation in Austin and Travis County as well as best practices in the state and other regions in order to make recommendations to the SFPB on city and county policies and practices aimed at improving participation in the program and tracking progress.
- Timeline: April to June 2011 report back to SFPB at June 27, 2011 meeting. Board unanimously agrees to accept SNAP Participation working group. Vote 11-0.

Urban Farming Best Practices (led by Allison Beadle)

- Purpose: Research and identify best practices/benchmarks used by municipalities effectively making resources available for sustainable urban farming (e.g., land, water, compost, training). Identify existing related definitions such as "sustainable agriculture," "urban agriculture," and "urban farm" and provide recommendations for working definitions.
- Timeline: April to July 2011 report back to SFPB at July 25, 2011 meeting. Members Paige Hill and Erin Flynn recused themselves from this item. Board voted to accept Urban Farming Best Practices working group. Vote 9-0.

Community Gardens Best Practices (led by Allison Beadle)

- Purpose: Research and identify best practices/benchmarks used by municipalities effectively
 making resources available for sustainable community gardens (e.g., land, water, compost,
 training). Identify existing related definitions and provide recommendations for working
 definitions.
- Timeline: April to July 2011 report back to SFPB at July 25, 2011 meeting. Board unanimously agrees to accept Community Gardens Best Practices working group. Vote 11-0.

Farmers Market Permitting (led by Paula McDermott)

- Purpose: To examine current permitting practices and fees for all farmers market
 participants in Austin and Travis County in order to identify optimal short and long-term
 permitting practices and fees that will facilitate a strong local food economy while ensuring
 safety. Include information on best practices/benchmarks within the state and in other
 regions while noting potentially shifting state regulations and definitions that impact
 permitting practices.
- Timeline: April to July 2011 report back to SFPB at July 25, 2011. Members Ronda Rutledge and Paige Hill recused themselves from this item. Board voted to accept Farmers Market Permitting working group. Vote 9-0.
