

WORK SESSION MEETING TUESDAY, MAY 24,2011

The City Council of Austin, Texas convened in a Special Called Meeting on Tuesday, May 24, 2011, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Leffingwell called the meeting to order at 9:07 a.m.

## COUNCILITEMS OF INTEREST (ACTIONITEMS)

- B.1 Approve a resolution canvassing the results of the May 14, 2011 General Municipal Election.

  Resolution No.20110524-B001 was approved on Council Member Riley's motion, Council Member Shade's second on a 7-0 vote.
- B.2 Approve the waiver of the deadline requirements and the closure notice which allows affected individuals and neighborhood associations to object to the closure under City Code Chapter 14-8 for the Sine Die event sponsored by the Mexican American Legislative Caucus which is to be held on Wednesday, May 25, 2011, from 12 noon until 12 midnight on West 13th Street between Colorado Street and Lavaca Street and on Colorado Street between 12th Street and 13th Street. (Mayor Lee Leffingwell and Mayor Pro Tem Mike Martinez)

The motion to approve the waiver of the deadline requirements and the closure notice which allows affected individuals and neighborhood associations to object to the closure for the Sine Die event sponsored by the Mexican American Legislative Caucus was approved on Mayor Pro Tem Martinez' motion. Council Member Cole's second on a 7-0 vote.
