# **REGULAR MEETING WEDNESDAY, APRIL 20, 2011**

The Downtown Commission convened in a regular meeting on Wednesday, April 20, 2011, at 301 W. 2<sup>nd</sup> St. in Austin, Texas.

A resolution that the rail alignment between downtown and the airport should be in dedicated right-of-way, to eliminate traffic interference and provide for time-certain arrival at the airport, and the project should have an email newsletter that can be subscribed to, was approved on Commission Member Willenzik's motion, Commission Member Sher's second, on a 10-0 vote.

A resolution that the Downtown Commission endorses this process that is being initiated with respect to significantly improving public transit possibilities in the urban core, was approved on Commission Member Haas' motion, Commission Member Willenzik's second, on an 8-0 vote, with Commission Members Guerrero and McGill off the dais.
