Dear Mayor Leffingwell, Mayor Pro-Tem Martinez, and City Council Members:

We are writing to express our extreme concerns about the development of a section along East 5th Street proposed by Mr. Kevin Johns, Director Economic Growth and Redevelopment Services Office (EGRSO) of the City of Austin. It is called the "Brownfield Economic Development Initiative (BEDI)/108 Regeneration Project"

- 1. The map presented to the Community Development Commission August 8, 2010 by Mr. Johns and staff has as the target area the entire Saltillo Plaza Transit Oriented District, which includes the Capital Metro site.
 - Yet EGRSO's memo dated October 29, 2010 shows that the BEDI target area boundaries are more limited—what was presented as Phase 1 in August. However, the memo lists key properties within Phase 1 that are outside that limited area, including the Saltillo Market Project and El Mundo Newspaper.
- 2. Staff has said that BEDI funds cannot be used for affordable housing—one of the projects the community has recommended for the area in question in not less than five studies done since the mid-1990s.
 - Yet the "Corazon Project" proposed as part of the BEDI is a live-work development that
 includes 85 residential condos with 51% allocated to families at 80% MFI. The median
 family income in this area is at 40 % MFI. The type of "affordable housing" being
 proposed is not affordable to the surrounding community. Any housing developed in the
 proposed BEDI project must be at 50% MFI or less.
- 3. Staff is proposing an artist's colony on site. We see this proposed development as similar to that which the Austin Revitalization Authority projects had on African American East Austin, opening the way for private developers to build huge apartment complexes that have led to the geometric growth of gentrification.
 - We believe that any further City of Austin redevelopment initiatives for Latino East Austin should be by, for, and about our people.

We the undersigned strongly stand in opposition to this development. Therefore, we urge you to instruct the City Manager to stop this development and the BEDI application process. It will only add to and encourage further gentrification. We further urge you to direct staff to turn over leadership, management, and oversight of the development of the Plaza Saltillo TOD to a locally organized and community managed non-profit corporation, not to a City department or private developer. This non-profit must have as its base local residents and business people who are committed to the preservation of the heritage and culture of the Latino Community while encouraging improvements that benefit everyone.

There are numerous examples of local community organizations running successful development projects around the country, e.g. The East Los Angles Community Union (Telacu) in Los Angeles, the Mexican-American Unity Council in San Antonio; and the Spanish Speaking Unity Council in San Francisco.

We further urge you to commit to fund land acquisition and infrastructure development for the project and assist with identifying appropriate private resources. This level of commitment is consistent with the findings of the Hispanic Quality of Life Initiative. Austin has a Spanish speaking population of around 35%, but we own less than one fourth of one per cent of total assets. The East Austin community needs to be and must be the lead when it comes to the type of development that goes into our neighborhoods. Neighborhood improvements and development cannot be accomplished without clear accountable protections for the residents and businesses of the area.

Who: The City of Austin's Community Development Commission, Neighborhood Housing and Community Development Department, Economic Growth and Redevelopment Services Office, and Planning & Development Review Department, want to work with you, the community where the Saltillo TOD District resides.


Where: Transit Oriented Development (TOD) District Boundary and Target Area Boundary (Phase 1)

- b. Target Area Boundaries: IH-35 on the West, North Alley of East 7th Street, Waller Street and East 3rd Street (Phase 1)

Why: For the Creation of Jobs, expanded Business and Economic Development, Sustainable Cultural Spaces, and Affordable Housing.

How: By securing federal funds as well as private investments designed to stimulate and promote economic and community development. This will be performed through a partnership between community members and the City of Austin.
