Authorize award and execution of Amendment No. 4 to a requirements supply contract with ENVIRONMENTAL RESOURCE ASSOCIATES, Austin, TX, for the purchase of water pollution and water supply proficiency testing standards for the Austin Water Utility, to exercise the final option in an estimated not to exceed \$25,000, for a revised total estimated contract amount not to exceed \$112,500.

### Amount and Source of Funding

Funding in the amount of \$12,500 is available in the Fiscal Year 2010-2011 Operating Budget of the Austin Water Utility. Funding for remaining six months of the option period will be contingent upon available funding in future budgets.

# Additional Backup Information

This contract is for the purchase of testing standards, which are required to be procured from a third party. The contractor supplies various parameters for proficiency testing programs, which ensure that quality control and standards mandated by the US Environmental Protection Agency (EPA) National Standards are met. Austin Water Utility's (AWU) accreditation by National Environmental Laboratory Accreditation Conference (NELAC) also depend upon these samples.

Austin Water Utility (AWU) Laboratory Services participates in an annual Discharge Monitoring Report Quality Assurance (DMRQA) testing program. The water pollution samples are accepted by the Texas Commission on Environmental Quality (TCEQ) as a substitute for DMRQA samples. These tests are supplied to be supplied to the United States Environmental Protection Agency as approved standards for water pollution and water supply proficiency testing.

This contract was competitively bid and awarded in 2008, in an amount of \$25,000 for the initial 12-months of a 24-month contract. Funding for year two of the initial 24-month contract and the first extension option were added administratively. An additional administrative increase was done to the contract in the amount of \$12,500. The recommended council

action is to approve Amendment No. 4 in the amount of \$25,000 for the final 12-month extension option, for a final contract value of \$112,500.
