Authorize award and execution of a 36-month requirements service with WASTE MANAGEMENT TEXAS, Houston, TX for disposal services for grit and screening from wastewater treatment plants for the Austin Water Utility in an amount not to exceed \$386,460, with three 12-month extension options in amounts not to exceed \$128,820 per extension option, for a total agreement amount not to exceed \$772,920.

## Amount and Source of Funding

Funding in the amount of \$64,410 is available in the Fiscal Year 2010-2011 Operating Budget of the Austin Water Utility. Funding for the thirty remaining months of the original contract period and extension options is contingent upon available funding in future budgets.

The debris will be collected at the screening facilities and the material collected will periodically be removed, hauled to and disposed of at the Creedmoor Landfill. The contractor will transport and dispose of the material in accordance with all Texas Commission on Environmental Quality, Environmental Protection Agency, and Texas Department of Transportation regulations.
