Additional Backup Information

This contract is for software maintenance and support for the Austin Police Department's Barcoded Evidence Analysis, Statistics, and Tracking Laboratory Information Management System (LIMS), which is used to support the forensic science division. The LIMS is used to perform quality assurance functions, document analysis information, and provides a platform for reporting. It also provides support in the areas of tracking evidence within the forensic division, the platform for customers to request analysis, and tracking of equipment, maintenance records, and inventory of supplies and equipment.

This contract was issued as a sole source contract in 2009. This recommended Council action is to approve Amendment No. 1 for \$25,137 and the authorization to enter into the two 12-month option periods for \$25,891.11 and \$26,667.84 respectively when appropriate, for a final contract value of \$124,435.95.
