## Subject

Authorize award and execution of a 36-month supply agreement with AUSTIN CRUSHED STONE, Austin, Texas, for crushed rock for the Watershed Protection Department in an amount not to exceed \$212,163 with three 12-month extension options in an amount not to exceed \$70,721 for each option, for a total contract amount not to exceed \$424,326.

### Amount and Source of Funding

Funding in the amount of \$29,467 is available in the Fiscal Year 2011 approved Operating Budget of the Watershed Protection Department. Funding for the remaining 31 months of the original contract period and for the extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

# Additional Backup Information

This contract establishes an annual supply agreement for crushed rock to for the Field Operations Division of the Watershed Protection Department on an as needed basis. Typical uses include; creek embankment and storm drain line stabilization; fill in small scouring holes in creek bottoms; to level trenched footings; temporary berms to aid erosion control; traction for earth moving equipment in slick areas; and French drain covers. This contract will supply the Watershed Protection Department with prompt availability of repetitive purchases for these materials. The materials are bulky, and the Field Operations crews do not have sufficient storage space for materials for more than a few medium size projects at a time.
