Additional Backup Information			

In November of 2006, voters approved an addition to the Emma S. Barrientos Mexican American Cultural Center (MACC) located at 600 River Street. This addition was a significant step in achieving the vision outlined in the Master Plan that was competed in 2000. CasaBella Architects, the prime architectural firm for the original facility, worked on this addition, which was called Phase 1A. The design principles of MACC Phase 1 were carried out in order to maintain design harmony and aesthetics. Phase 1A was completed in the spring of 2010. The original building was completed in June of 2007.

This authorization will also provide a preliminary analysis of the facility's parking requirements in order to alleviate the current parking congestion. The project is located in zip code 78701.

In August of 2010, Council approved ordinance 20100819-033 to rename the Mexican American Cultural Center after the late Emma Barrientos, a longtime community organizer who worked for decades to make the center a reality. Council voted unanimously to rename the center the "Emma S. Barrientos Mexican American Cultural Center". This additional authorization will allow for design services to change the facility signage while maintaining the harmony and aesthetics of the building.
