## Subject

Authorize award and execution of Amendment No. 1 to a contract with LIQUID ENVIRONMENTAL SOLUTIONS OF TEXAS LP, Austin, TX for grease trap and car wash rack maintenance services for the Aviation Department to provide funding in the amount not to exceed \$12,266 for the third 12-month period of the initial 36-month contract, with three additional 12-month extension options in an amount not to exceed \$12,266 per extension option, for a revised total contract amount not to exceed \$73,596.

## Amount and Source of Funding

Funding in the amount of \$4,088 is available in the Fiscal Year 2010-2011 Operating Budget of the Aviation Department. Funding for the remaining four months of the original contract and extension options is contingent upon available funding in future budgets.

This agreement is for the grease trap and car wash rack maintenance and sludge disposal services at the Austin-Bergstrom International Airport. These services cover the removal of hazardous waste from grease traps and wash rack with proper disposal to other waste facilities.

This recommended Council action is to Amendment No. 1 in an amount not to exceed \$12,266 for the final 12-month period of the 36-month agreement and the authorization to enter into 3 12-month option periods for \$12,266 each when appropriate, for a final contract amount of \$73,596.
