Authorize award and execution of Amendment No. 2 to exercise the first of three 12-month extension options of a requirements service contract with PROGRESSIVE ENVIRONMENTAL SERVICES, INC., Eastland, TX., for the purchase of rapid response remediation services in an estimated amount not to exceed \$48,600 with two 12-month extension option in an estimated amount not to exceed \$48,600 per extension option, for a total revised contract amount not to exceed \$291,600.

Amount and Source of Funding

Funding in the amount of \$48,600 is available in the Fiscal Year 2010 – 2011 Operating Budget for the Watershed Protection Department. Funding for the remaining option will be contingent upon available funding in future budgets.

Additional Backup Information

This contract is for the purchase of rapid response remediation services for Watershed Protection Department. These services are for hazardous and non-hazardous spills on City properties that are not the responsibility of a specific City department, such as road right of ways and drainage ways. In addition, this contract will be used where a responsible party cannot be identified, cannot or will not respond, or when the spill necessitates immediate action. The Contractor will be able to respond to any and all hazardous and non-hazardous material spills to land or water, including but not limited to petroleum spills from traffic accidents, and illegal dumping.

This contract was competitively bid and awarded in 2007, in an amount of \$48,600 for the initial 12-months of a 36-month contract. Funding for years one, two and three of the initial 36-month contract were added administratively. The recommended council action is to approve Amendment No. 1 in the amount \$48,600 and the authorization to enter into the final two option period when appropriate, for a final contract value of \$291,600
