Authorize award and execution of Amendment No. 1 to a contract with NUNN ELECTRIC SUPPLY dba Border States Electric Supply, Austin, TX for airfield lamps to provide funding in the amount not to exceed \$49,000 for the third 12-month period of the initial 36-month contract, with three additional 12-month extension options in an amount not to exceed \$49,000 per extension option, for a revised total contract amount not to exceed \$294,000.

Amount and Source of Funding

Funding in the amount of \$16,333 is available in the Fiscal Year 2010-2011 Operating Budget of the Aviation Department. Funding for the remaining four months of the original contract and extension options is contingent upon available funding in future budgets.

Additional Backup Information

This agreement is for replacement airfield lighting fixtures, lamps and signage panels. This is one of 4 agreements that are used to maintain the airfield lighting and signage system for ABIA.

This contract was competitively bid in 2008. The contract was awarded to Nunn Electric Supply as an alternate vendor by line item. This recommended Council action is to approve an administrative increase in an amount not to exceed \$49,000 for the final 12-month period of the 36-month agreement and the authorization to enter into the final option periods for \$49,000 each when appropriate, for a final contract amount of \$294,000.
