Authorize negotiation and execution of Amendment No. 7 to an Interlocal Agreement with the University of North Texas for a native vegetation restoration project to be conducted in Lake Austin and Lady Bird Lake for prevention of invasive riparian plant growth in an amount not to exceed \$30,000, for a revised contract amount not to exceed \$525,000.

On March 2, 2005, the City entered into the Interlocal Agreement with the University of North Texas for a program to establish native aquatic plant founder colonies to provide habitat for fish and other aquatic wildlife, to maintain benefits of improved water quality associated with aquatic vegetation, to reduce re-infestation of hydrilla in Lake Austin, and to reduce the likelihood of infestation of hydrilla in Lady Bird Lake. Six previously approved amendments to the Interlocal Agreement have expanded the program, adding more founder colonies, and expanding, monitoring and managing existing colonies.

These founder colonies of native plants have been successfully established at all sites and have shown initial spread beyond the enclosures. Increased growth and spread has been seen at sites with larger pens, which will help target efforts in the future as the City continues work to enhance native plant communities in Lake Austin and Lady Bird Lake

Amendment No. 7 adds \$30,000 to the agreement for the assessment and management of invasive plants (elephant ear and giant cane) along the shoreline of Lady Bird Lake. Giant cane and elephant ear are two of the most aggressive invaders along Lady Bird Lake shoreline. They form monocultures (large areas with only one type of plant) that dominate the plant communities, eliminating diversity and providing very little ecological benefit such as wildlife food or cover. The amendment will provide mapping and assessment services, as well as the development of a guidance document for control of these invasive species. Native aquatic and emergent plants will be introduced in control areas. A demonstration study to evaluate specific methods of control for elephant ear will be conducted.
