Authorize award and execution of a 4-month requirements supply contract through the Texas Local Government Purchasing Cooperative (BuyBoard) with COOPER EQUIPMENT COMPANY, San Antonio, TX. for the rental of heavy-duty road-repair equipment in an estimated amount not to exceed \$49,600 with two 12-month extension options in an estimated amount not to exceed \$97,960 for the first extension option and \$136,896 for the second extension option, for a total estimated contract amount not to exceed \$284,456.

Amount and Source of Funding

Funding in the amount of \$49,600 is available in the Fiscal Year 2010-2011 Operating Budget of the Public Works Department. Funding for the extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backum Information			

This contract is for the monthly rental of heavy-duty pneumatic rollers to be used for the Public Works Department's Sealcoat Program.

Sealcoat is a thin asphalt-emulsion surface treatment which helps to waterproof, or seal, small cracks in the existing road surface which prevents large pot-holes from forming. Sealcoating is a cost-effective preventive maintenance measure and extends the overall life of the road surface. Sealcoat season typically runs from the beginning of April to the end of October.

As part of the sealcoat process, a pneumatic roller is used to embed aggregate into the asphalt emulsion.

Rentals to be provided under this contract are newer-models, manufactured since 2011, which utilize the latest technology in emissions control. The units are capable of burning biodiesel (B20) fuel. In keeping with Austin Climate Protection Program goals, B20 provides an approximate 25% reduction in greenhouse gas emissions versus using gasoline and an approximate 5% reduction versus using petro-diesel.

The Purchasing Office conducted an analysis to determine that the Equipment BuyBoard contract was the best value to the City. This contract offered the lowest monthly rental prices and is able to provide equipment that fully meets the needs of the Public Works Department. Cooper Equipment is contracted through BuyBoard to supply this type of equipment to other public entities statewide as a result of a competitive bidding process. Utilizing BuyBoard contracts provides for volume discount pricing as well as the earliest opportunity to place the City's vehicles on order
