Additional Backup Information						

The mission of the Watershed Protection Department (WPD) is to reduce the impact of flooding, erosion, and water pollution on our community in order to protect lives, property and the environment. In 2009, the WPD identified a number of watersheds that warranted updated floodplain modeling and mapping studies. Based on several factors, including floodplain study age and available budget, WPD's project planning identified approximately \$1,500,000 in studies. In March 2010, City Council authorized WPD to enter into professional service agreements (PSA) with two consultant teams to complete these studies for a total funding authority of \$2,000,000 through the 2010 Floodplain Modeling and Mapping Rotation List. The City and consultants negotiated and approved the PSAs in April 2010. Several floodplain studies have subsequently been initiated.

On September 27, 2010, FEMA awarded the City of Austin \$1,100,000 in grant funds to support the development of floodplain modeling and mapping studies. Based on this additional funding, the WPD is able to provide floodplain studies for additional portions of the City in need of updated floodplain mapping through the 2010 Floodplain Modeling and Mapping Rotation List. WPD is requesting through CLMD that the funding authority for this rotation list be increased by \$1,000,000 for a total authorization of \$3,000,000. The FEMA grant (EMT-2010-CA0011) stipulates a performance period during which the floodplain studies must be completed. Using the existing rotation list will allow the projects to be completed without risking the loss of grant funds.

The selected engineering consultants shall conduct these floodplain modeling and mapping studies in accordance with all applicable City of Austin and FEMA specifications and criteria. In addition, the consultants are implementing MBE /WBE Compliance Plans, which were approved by the Small and Minority Business Resources Department.
