The Austin Water Utility has an on-going project to investigate the cause of leaking water at a reclaimed water ground storage tank at the Walnut Creek Wastewater Treatment Plant. The tank is critical to the operation of the reclaimed water in central Austin. Realizing the criticality of the tank and the consequences of its failure, the Utility arranged for the design of a by-pass line and began to purchase materials for the by-pass line construction. On April 12, a new leak was noted at the tank. This leak was fundamentally different in nature than previous leaks and continued to grow in volume over the next few days. An emergency affidavit was executed to purchase the materials to construct the by-pass line. The ground storage tank has been drained and a temporary patch has been put in place to minimize the leakage while the by-pass line is constructed.
