Approve Amendment No. 4 to increase a continuing contract with the AMERICAN RED CROSS., Austin, TX, for training, certification and materials in an estimated amount not to exceed \$17,700 with automatic one-year renewals thereafter on the anniversary of the commencement date, unless either party gives written notice to the other of its desire not to renew at least 30 days prior to the commencement of any renewal period; respectively in the amount of \$17,700 per automatic one-year renewal.

Amount and Source of Funding

Funding in the amount of \$17,700 is available in the Fiscal Year 2010 – 2011 Operating Budget for the Parks and Recreation departments. Funding for the remaining option will be contingent upon available funding in future budgets.

This contract provides first aid, CPR, aquatics, water safety, HIV/AIDS prevention education, and other health and safety education programs for the Parks and Recreation Department.

This contract was awarded as a sole source in 2008, in an amount of \$16,500, with the express intention of a continuing contract subject to annual review and extension. Funding for years one, two and three were added administratively. The recommended council action is to approve Amendment No. 4 in the amount \$17,700 and the authorization to enter automatic one-year renewals per the terms of the contract for the next ten years as appropriate, with each annual estimate not to exceed \$17,700.
