Authorize award and execution of a 36-month requirements service contract with MAGNA-FLOW ENVIRONMENTAL, INC., Austin, Texas, for grit trap-septic pumping, hauling and disposal services for the Solid Waste Services Department in an amount not to exceed \$198,135 with three 12-month extension options in an amount not to exceed \$66,045 per extension option, for a total contract amount not to exceed \$396,270.

## Amount and Source of Funding

Funding in the amount of \$11,008 is available in the Fiscal Year 2010- 2011 approved Operating Budget of the Solid Waste Services Department. Funding for the remaining thirty four months of the original contract period and for the extension options is contingent upon available funding in future budgets.

**PRICE ANALYSIS**

- Adequate competition.
- Forty-nine notices were sent, including seven MBE's. There are no known WBE's for this commodity code. Three bids were received, with no responses from the MBE /WBEs.
- The pricing offered represents a 6.5 % decrease to the last contract award in August 2008.
