Additional Backup Information	

This additional authorization is requested to complete the design for the second phase of the Pfluger Bridge Extension Project, which will include the Bowie Underpass, Union Pacific Railroad (UPRR) Bridge span replacement, and North Lamar Pedestrian Crossing. This project will provide a safe passage and alternative transportation choice for bicyclists and pedestrians across the barrier formed by the UPRR.

This project will form the primary bicycle and pedestrian link between two recent residential and commercial development areas separated by Lady Bird Lake. The Bowie Underpass will connect users to the proposed Seaholm Lone Star Rail/Urban Rail transfer station. This project will also replace the northernmost span of the existing UPRR Lady Bird Lake Bridge, which is located over the newly constructed 2<sup>nd</sup> Street, with a new ballasted deck, as required by UPRR.

The design of the pedestrian underpass is approximately 30% complete. Negotiations with UPRR resulted in the addition of the bridge span replacement and a controlled surface crossing west of Lamar. In order to construct the underpass while maintaining rail service, the rail line will be slightly realigned within the existing right of way from the north end of the bridge over Lady Bird Lake to Lamar. This realignment requires the bridge span replacement and underpass to be constructed concurrently and all elements of the project to be designed together.

This project is managed by the Public Works Department.
