Authorize award and execution of a 12-month requirements supply contract with MCCAIN INC., League City, TX, for the purchase of 30 "Traffic Signal Cabinets (342 ITS cabinet type) in an amount not to exceed \$284,310 with two 12-month extension options in an amount not to exceed \$284,310 per extension for a total contract amount not to exceed \$852,930.

Amount and Source of Funding

Funding in the amount of \$284,310.00 is available in the Fiscal Year 2010–2011 Capital Budget (2010 bond) of the Austin Transportation Department, Traffic Signal Division. Funding for extension options is contingent upon available funding in future budgets.

Additional Backup Information

The Austin Transportation Department, Traffic Signal Division is requesting to purchase these Traffic Signal Cabinets for installation at new signalized intersections, or to be used for upgrading existing signalized intersections where additional capability, and efficiency is needed to run the intersections safer and more efficiently. These cabinets also provide capability to run more than one intersections using one traffic signal controller. The result is one less traffic signal cabinet and one less traffic signal controller, that is a saving of almost 50% in procurement costs.
