Authorize award and execution of a 36-month requirements service contract with BLACKMON MOORING OF TEXAS, INC., Austin, TX, to provide applied structural drying services for the Austin Water Utility in an estimated amount not to exceed \$180,000, with three 12-month extension options in an estimated amount not to exceed \$60,000 per extension option, for a total estimated contract amount not to exceed \$360,000.

## Amount and Source of Funding

Funding in the amount of \$5,000 is available in the Fiscal Year 2010-2011 Operating Budget of the Austin Water Utility. Funding for the remaining thirty-five months of the original contract period and extension options is contingent upon available funding in future budgets.

These services are required to clean business and residential housing when a water main breaks or a back-up occurs from sanitary sewer overflows (SSO) within the wastewater collection system resulting from a failure in the City's infrastructure.

#### **PRICE ANALYSIS**

- b. One hundred twenty-four notices were sent, including seventeen MBEs and two WBEs. One bid was received, with no response from the MBEs/WBEs. One "No Bid" was received.
- c. The pricing offered represents an approximate 8% increase from the last contract award June 2007.
