Subject

Authorize award and execution of a 36-month requirements service contract with AUSTIN HI-TECH RESTORATION, INC. Austin, TX, or one of the other qualified bidders for IFB-BV No. PAX0209, for temporary fencing and boarding in an estimated amount not to exceed \$535,080, with three 12-month extension options in estimated amounts not to exceed \$254,016 for the first extension option, \$304,819 for the second extension option, and \$365,783 for the third extension option, for a total estimated contract amount not to exceed \$1,459,698.

Amount and Source of Funding

Funding in the amount of \$24,500 is available in the Fiscal Year 2010-2011 Operating Budget of various City Departments. Funding for the remaining 34 months of the original contract period and extension options is contingent upon available funding in future budgets.

Fiscal Note

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information

This contract will provide for the delivery, placement, maintenance, and removal of temporary fencing and boarding. Temporary fencing is required for public safety or security, crowd control, theft deterrent, or equipment storage. Temporary board up is required to prevent property from storm damage as well as to secure a facility or property from unauthorized access.

City departments that will utilize this contract include the Financial and Administrative Services Department, Parks and Recreation Department, Austin Water Utility, Code Compliance Department, Aviation Department, Emergency Medical Services Department, Fire Department, and the Police Department.

In order to determine the best value to the City, evaluation criteria included the labor rate, cost of material, and the ability to provide other types of fencing.

This request allows for the execution of a contract with a bidder, who provides the best value to the City, that Council selects. If this bidder does not execute a contract with the City, staff will return to Council so that Council may select another best-value bidder and authorize a contract with this bidder.
