Authorize award and execution of a 36-month requirements supply contract with INDUSTRIAL DISPOSAL SUPPLY CO., INC. San Antonio, TX to provide repair parts and services for Advance street sweepers in an estimated amount not to exceed \$255,232, with three 12-month extension options in amounts not to exceed \$118,874 for the first extension option, \$141,569 for the second extension option, and \$168,803 for the third extension option, for a total estimated contract amount not to exceed \$684,478. Industrial Disposal Supply Co., Inc, is the single source provider for these parts and services.

Amount and Source of Funding

Funding in the amount of \$5,922 is available in the Fiscal Year 2010-2011 Operating Budget of the Financial and Administrative Services Department, Fleet Fund. Funding for the remaining 35 months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract is for the supply of Original Equipment Manufacturer (OEM) repair parts used by Fleet Services technicians for preventative maintenance and repairs of Advance street sweepers. The Contractor will also provide repair services on an as-needed basis. The repair services will be used to supplement the Advance street sweeper repairs normally performed by technicians at the Fleet Service Centers.

The Advance street sweepers which will be serviced under this contract are high-pressure surface cleaners utilized in the downtown streetscape maintenance program and are used for sidewalk cleaning. The street sweepers have a very small footprint and can easily remove waste and petroleum deposits from concrete and asphalt sidewalks. The street sweepers use a unique water recycling process. As water is cycled through the system, the contaminants are filtered out and contained, allowing the water to be reused. These cleaners eliminate the use of hoses and surface runoff, thereby reducing the risk of groundwater contamination.

Industrial Disposal Supply is the only dealer authorized to provide parts and repairs for Advance street sweepers in the Greater Metropolitan Austin Area.
