#### Subject

Authorize award and execution of Amendment No. 1 to a contract with POLLYANNA THEATRE CO., Austin, TX, to provide outreach live performance program services for Solid Waste Services Department, to extend the contract for one 12-month period in an estimated amount not to exceed \$19,060, with two additional 12-month extension options in the amount of \$19,060 per extension option, for a revised total contract amount not to exceed \$114,360.

### Amount and Source of Funding

Funding in the amount of \$19,060 is available in the Fiscal Year 2010 - 2011 Operating Budget for the Solid Waste Services Department. Funding for the remaining option will be contingent upon available funding in future budgets.

## Additional Backup Information

This contract is for the purchase of outreach production and performance program services for Solid Waste Services Department. These program services include production and live performance of a math-based recycling educational class called "Recycling Adds Up". The class targets students in Grade 3 at Austin Independent School District (AISD) elementary schools as well as to elementary schools in surrounding school districts located in areas served by City of Austin Solid Waste Services.

This contract was competitively bid and awarded in 2009, in an amount of \$19,060 for the initial 12-months of a 36-month contract. Funding for years one and two of the initial 36-month contract were added administratively. The recommended council action is to approve Amendment No. 1 in the amount \$19,060 for the third 12-months of the initial contract period, and the authorization to enter into the first of three 12-month option periods when appropriate, for a final contract value of \$114,360.
