This contract is for the licensing and maintenance of RescueNet TabletPCR (ePCR) system software, which is the system of record for documenting patient information and care provided by Austin Travis County paramedics.

This proposed amendment is to incorporate maintenance and support for RescueNet billing system software, which is used to generate invoices for EMS services rendered, track account status, and record payments received. The billing system is interfaced with the Zoll ePCR system, which downloads patient demographics and other trip data into the billing system to generate patient account records.

The billing system software was purchased in 1999. The ePCR system was purchased in 2008. Both systems were purchased using the competitive Request for Proposal process.
