

# THE LIBRARY COMMISSION MINUTES

REGULAR MEETING 25, July, 2011

## 2. Approval of Minutes

The minutes from the Regular Called Meeting of 6/27/2011 were approved on a 4-0-0 vote Those members voting aye were: Chair Martin, and Commission Members Fox, Goldston and Pleasant

#### 3. Presentation: Downloadables at APL

Yolanda McKnight, Consumer Services Manager – APL has contracted with Overdrive to launch downloadables in the winter of 2011. APL customers will need a Library card and PIN along with internet access to be able to download. Customers can check out three titles at a time and place five on hold.

#### 4. New Business

a. Discussion and Action on the need for a retreat

Motion by Commission Member Fox to move the discussion to meeting date where Vice Chair Todd is in attendance did not pass on a vote of 3-0-1 due to lack of quorum

b. Branch Liaison Briefings

- 1) Commission Member Goldston reported that information about Recycled Reads will appear in the August enclosure of Austin Energy bills. The University Hills branch will be celebrating its 25<sup>th</sup> anniversary on August 13. Regional Branch Manager Diane Palan has been assisting at the Spicewood Springs Branch
- 2) Commission Member Fox visited the Windsor Park branch and was impressed with the staff and their work with the community.
- 3) Commission Member Pleasant meet with Managing Librarian Carolyn Rogers at the Faulk Central Library. Carolyn explained the ongoing weeding process in the Reference section as more reference publications become electronic. This process has freed up space to add more seating.
- 4) Chair Martin attended the Friends Foundation board meeting and reported that the Foundation is hosting a Teen Book Festival October 1, at the Palmer Event Center. They are coordinating with Book People and AISD.
