1 **AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE**
2 **PROPERTY LOCATED AT 1701 SCOFIELD LANE FROM NEIGHBORHOOD**
3 **OFFICE (NO) DISTRICT TO GENERAL OFFICE-CONDITIONAL OVERLAY**
4 **(GO-CO) COMBINING DISTRICT.**

6 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

8 **PART 1.** The zoning map established by Section 25-2-191 of the City Code is amended to
9 change the base district from neighborhood office (NO) district to general office-
10 conditional overlay (GO-CO) district on the property described in Zoning Case No. C14-
11 2011-0069, on file at the Planning and Development Review Department, as follows:

13 Lot 1, Block A, Scofield Montessori Subdivision, a subdivision in the City of
14 Austin, Travis County, Texas, according to the map or plat of record in Document
15 No. 200900082 of the Official Public Records of Travis County, Texas (the
16 "Property"),

17
18 locally known as 1701 Scofield Lane, in the City of Austin, Travis County, Texas, and
19 generally identified in the map attached as Exhibit "A".

20
21 **PART 2.** The Property within the boundaries of the conditional overlay combining district
22 established by this ordinance is subject to the following conditions:

- 23
24 A. A site plan or building permit for the Property may not be approved, released,
25 or issued, if the completed development or uses of the Property, considered
26 cumulatively with all existing or previously authorized development and uses,
27 generate traffic that exceeds 2,000 trips per day.

29 B. The maximum height of a building or structure on the Property is 40 feet from
30 ground level.

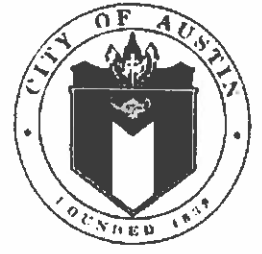
