This working group will work with local water policy experts and City and County staff to determine how to better support sustainable food production, keeping in mind past mistakes and shortcomings related to water for local farms, the ongoing drought, and working within the limitations of State "rule of capture" water law. Recommendations for action will be made to the Austin/Travis County Sustainable Food Policy Board
