## Subject

Authorize award and execution of a 24-month requirements service contract with WASTEWATER TRANSPORT SERVICES, LLC, Austin, TX, for sludge and sewage pumping, hauling and disposal services for the Austin Water Utility in an estimated amount not to exceed \$83,440, with two 12-month extension options in an estimated amount not to exceed \$41,720 per extension option, for a total estimated contract amount not to exceed \$166,880.

# Amount and Source of Funding

Funding in the amount of \$41,720 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility. Funding for the remaining 12-months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract is to provide sludge and sewage pumping, hauling and disposal services for the Austin Water Utility on an as needed basis. The contract will pump and transport the materials in accordance with Texas Commission on Environmental Quality, Environmental Protection Agency, and Texas Department of Transportation regulations, to disposal locations at the South Austin Regional or Walnut Creek Wastewater Treatment Plants (WWTP). This service is for scheduled hauling of waste and is necessary to maintain proper operations of the facilities to ensure permit requirements are met.

Services will be provided to Harris Branch WWTP, Thoroughbred Farms WWTP, Dessau WWTP and Onion Creek Water Reclamation Plant, all of which are located in Travis County. Hauling from these facilities is necessary since these facilities are not tied into the City's wastewater systems at South Austin Regional or Walnut Creek Wastewater Treatment Plant.
