


# **PLAN ORGANIZATION**

- 1. Historic Preservation
- 2. Activities and Uses
- 3. Density and Design
- 4. The Public Realm
- 5. Transportation and Parking
- 6. Infrastructure and Utilities
- 7. Leadership and Implementation

# **RECOMMENDATION FOR COUNCIL ACTION**

1. Adopt the Downtown Austin Plan (including the staff-recommended amendments) as an amendment to the Austin Tomorrow Plan.

And, because the Downtown Austin Plan is a "planning" document and does <u>not</u> contain re-zonings, code amendments, or other regulatory actions . . .

- 2. Direct the City Manager to initiate the code amendments as recommended in the Plan, including but not limited to:
  - Regulating Plan that implements Downtown-specific development standards.
  - Creation of new zoning districts (e.g., DMU-60)
  - Downtown Density Bonus Program
  - Downtown-specific compatibility framework.
- 3. Direct the City Manager to initiate the re-zonings as recommended in the Plan.

## **RECOMMENDATION FOR COUNCIL ACTION**

4. Direct the City Manager to include implementation projects identified in the Downtown Austin Plan as part of the City's comprehensive capital project needs assessment and prioritization and identify possible funding strategies for these elements of the Plan.

5. Direct the City Manager to develop a detailed plan (including the steps and schedule) for creating a Central City Economic Development Corporation and present that plan to City Council for consideration and possible action.
