Authorize award and execution of a 36-month service contract with ANDY J. WILHELM, SAN MARCOS, TX, or one of the other qualified bidders for IFB-BV No. SDC0164, for vegetation control at eighty creek buffer ponds for the Watershed Protection Department in an amount not to exceed \$90,240, with three 12-month extension options in an amount not to exceed \$30,080 per extension option, for a total contract amount not to exceed \$180,480.

Amount and Source of Funding

Funding in the amount of \$30,000 is available in the Fiscal Year 2011-2012 Operating Budget of the Watershed Protection Department. Funding for the remaining 24 months of the original contract period and for the extension options is contingent upon available funding in future budgets.

Additional Backup Information

This contract will provide vegetation control at eighty (80) City maintained ponds located within the stream buffers of the Barton Spring Zone. Due to the sensitivity of this area, these ponds require specialized vegetation management that ensures minimal disturbance to the surroundings. Under this contract, each pond will be mowed at least three times a year and invasive woody plants will be removed on a quarterly basis. This level of maintenance will ensure each pond is compliant with the Environmental Criteria Manual, Drainage Criteria Manual, and dam maintenance policies and procedures while following site-specific Intergraded Pest Management (IPM) plans.

PRICE ANALYSIS

- a. Adequate competition.
- b. One hundred fifty-eight were sent, including 7 MBEs and 5 WBEs. Four bids were received, with no responses from the MBE or WBE firms.
- c. The pricing offered represents a 58% decrease from the last contract award. This can be attributed to the lowering gas prices.
