

# DOWNTOWN COMMISSION MINUTES

# **REGULAR MEETING**WEDNESDAY, AUGUST 17, 2011

The Downtown Commission convened in a regular meeting on Wednesday, August 17, 2011, at 301 W. 2<sup>nd</sup> St. in Austin, Texas.

#### 3. APPROVAL OF MINUTES

# 4. PROPOSED ORDINANCE AMENDMENT TO REDUCE PARKING REQUIREMENTS FOR PROPERTY ZONED P-PUBLIC IN THE DOWNTOWN AREA

After receiving a briefing, a resolution to support the ordinance amendment was approved on Commission Member Haas' motion, Commission Member Willenzik's second, on a 10-0 vote.

#### 5. NEW ITEMS FOR INFORMATION FROM COMMISSION MEMBERS

Commission Member Lanier spoke on the issue of the impacts of development (especially parking) on nearby neighborhoods.

Commission Member Oveisi spoke on three issues: 1) the proposed designation of Red River as an Entertainment District, 2) the ongoing conflict between residential development and noise impacts, especially from outdoor music venues, and 3) the need for musician load-in areas in entertainment districts.

Staff liaison Michael Knox reminded the Commission of the schedule for the Downtown Austin Plan approval process.

Staff liaison Michael Knox spoke of the need for the Downtown Commission to designate a representative to the Seaholm Substation Wall Art AIPP project; Commission Member Stan Haas was designated.
