| Chapter 26 of the Texas Parks and Wildlife Code provides that the use of parkland for non-park purposes may be approved upon a finding that there is no feasible and prudent alternative to the use of this land. | | | | | | | |
| The Holly Street Power Plant Decommissioning and Demolition will require the use of parkland located at Metz Park, including the Metz Recreation Center south parking lot, as a haul route for materials removed from the plant. Because this haul route to and in Pedernales Street will be dedicated and barricaded, the existing parking for the Park users will be unavailable for the duration of the project. Austin Energy will mitigate the inaccessible parking by the construction and removal of a temporary parking lot with access sidewalks on parkland and a cash transfer as mitigation for the use of parkland. | | | | | | | |
| Approval of the use of parkland is made on the condition that all restoration is completed in accordance with the Standard Specifications and Construction Standards of the City of Austin and the Parks and Recreation Department's "Construction in Parks Specifications". Austin Energy Department is required to pay all costs associated with the | | | | | | | |

restoration and tree mitigation as part of the site restoration process.
