# AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 2935 EAST MARTIN LUTHER KING, JR. BOULEVARD FROM FAMILY RESIDENCE-NEIGHBORHOOD PLAN (SF-3-NP) COMBINING DISTRICT TO NEIGHBORHOOD COMMERCIAL-MIXED USENEIGHBORHOOD PLAN (LR-MU-NP) COMBINING DISTRICT. 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from family residence-neighborhood plan (SF-3-NP) combining district to neighborhood commercial-mixed use-neighborhood plan (LR-MU-NP) combining district on the property described in Zoning Case No. C14-2011-0084, on file at the Planning and Development Review Department, as follows:

A 0.19 acre tract of land, more or less, out of the East Center 52 feet of the north 158.70 feet in Lot 1 in Outlet 28, Division B, the original City of Austin in Travis County, Texas, the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),
locally known as 2935 East Martin Luther King, Jr. Boulevard in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit " B ".

PART 2. Except as specifically provided in Part 3 of this ordinance, the Property may be developed and used in accordance with the regulations established for the neighborhood commercial (LR) base district, the mixed use and other applicable requirements of the City Code.

PART 3. The Property is subject to Ordinance No. 020110-17 that established the Rosewood neighborhood plan combining district.

PART 4. This ordinance takes effect on 2011.
