AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 820 WEST YAGER LANE FROM LIMITED INDUSTRIAL SERVICE (LI) DISTRICT TO GENERAL COMMERCIAL SERVICES-COMMERICAL OVERLAY (CS-CO) COMBINING DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from limited industrial service (LI) district to general commercial services-commercial overlay (CS-CO) combining district on the property described in Zoning Case No. C14-2011-0075, on file at the Planning and Development Review Department, as follows:

Lot 1, Block A, Yeager Acers Subdivision, a subdivision in the City of Austin, Travis County, Texas, according to the map or plat of record in Plat Book 75, Page 40, of the Plat Records of Travis County, Texas (the "Property"),

locally known as 820 West Yager Lane, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "A".

- **PART 2.** The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:
 - A. A site plan or building permit for the Property may not be approved, released, or issued, if the completed development or uses of the Property, considered cumulatively with all existing or previously authorized development and uses, generate traffic that exceeds 2,000 trips per day.
 - B. The following uses are prohibited uses of the Property:

Outdoor Entertainment
Art Workshop
Automotive Rentals
Automotive Washing (of any type)
Custom Manufacturing
Convenience Storage
Equipment Repair Services

Art Gallery
Automotive Repair Services
Automotive Sales
Bail Bond Services
Agricultural Sales and Services
Vehicle Storage
Equipment Sales




