## ORDINANCE NO. 20111103-019

AN ORDINANCE SETTING THE COUNCIL MEETING SCHEDULE FOR CALENDAR YEAR 2012 AND WAIVING CERTAIN REQUIREMENTS OF CITY CODE SECTION 2-5-24.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

## PART 1. FINDINGS:

- (A) Council finds that City Charter Article II, Section 10, establishes that Council will meet in regular session at the City Hall at least once each week at such time as may be prescribed by ordinance, unless otherwise ordered by the council for reasons to be spread upon the minutes.
- (B) Council has set its regular meetings by ordinance, as set forth in City Code Section 2-5-24.
- (C) Council desires to provide notice of its regular meetings dates, work session dates, and dates on which it will not meet.
- (D) The reasons for which council is cancelling certain of its meetings and waiving the provisions of City Code Section 2-5-24 is to allow recesses for holidays and time to conduct other City business.
- **PART 2.** Council orders that it will meet as set forth in the schedule attached to this Ordinance as Exhibit A.
- **PART 3.** Council waives the requirement of City Code Section 2-5-24 to hold its meetings every Thursday to allow recesses for holidays and time to conduct other City business.
