# Memorandum To:

# RESOLUTION

A RESOLUTION by the City Council of the City of Austin, Texas, canvassing returns and declaring the result of a bond election held in said City on the 14th day of December, 1985.

WHEREAS, this governing body ordained that an election be held within this City on the 14th day of December, 1985, for the purpose of submitting certain propositions for the issuance of bonds to the resident electors of the City; and,

WHEREAS, it is hereby found and determined that said election was held in accordance with the authorizing proceedings, that notice of the election was duly given in the form, manner and time required by law, and that said election was in all respects legally held and conducted in accordance with the laws of the State of Texas applicable thereto; and,

WHEREAS, the returns of the said election have been made to this governing body and said returns, duly and legally made, show the following votes were cast on the propositions submitted at said election, to-wit:

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS:

<u>SECTION 1</u>: That all of the recitals contained in the preamble of this resolution are found to be true and are adopted as findings of fact by this governing body and as part of its judgment.

SECTION 2: It is further found and determined that the results of the election as canvassed and tabulated in the preamble hereof reflect the expressed desires of those persons voting at said election.

<u>SECTION 3</u>: That a majority of the resident qualified electors voting at said election having voted in favor of Propositions Numbers 1-16, the City Council of said City is authorized and empowered to issue bonds on behalf of said City in the amounts and for the purposes prescribed in Propositions Numbers 1-16 in the proceedings calling the election.
