# AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 6607 NORTH IH-35 SERVICE ROAD NORTHBOUND FROM GENERAL COMMERCIAL SERVICES (CS) DISTRICT TO COMMERCIAL-LIQUOR SALES-CONDITIONAL OVERLAY (CS-1-CO) COMBINING DISTRICT. 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from general commercial services (CS) district to commercialliquor sales-conditional overlay (CS-1-CO) combining district on the property described in Zoning Case No. C14-2011-0112, on file at the Planning and Development Review Department, as follows:

A 0.352 acre tract of land, more or less, out of a portion of La Costa Subdivision in Travis County, the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),
locally known as 6607 North IH-35 Service Road Northbound, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "B".

PART 2. The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:

A site plan or building permit for the Property may not be approved, released, or issued, if the completed development or uses of the Property, considered cumulatively with all existing or previously authorized development and uses, generate traffic that exceeds 2,000 trips per day.

Except as otherwise specifically restricted under this ordinance, the Property may be developed and used in accordance with the regulations established for the commercialliquor sales (CS-1) base district, and other applicable requirements of the City Code.

PART 3. This ordinance takes effect on November 21, 2011.

3.) N 03 deg. $30^{\prime} 44^{\prime \prime} \mathrm{W} 152.52 \mathrm{ft}$. to a calculated point at a point of curvature for the most Westerly Northwest corner of the herein described tract;
4.) along a curve to the right with a radius of 6.00 ft . for an arc length of 10.28 ft . and which chord bears, $\mathrm{N} 45 \mathrm{deg} .25^{\prime} 23^{\prime \prime}$ E 9.07 ft . to a calculated point at a point of tangency for the most Northerly Northwest corner of the herein described tract;
5.) S 84 deg. $47^{\prime} 23^{\prime \prime}$ E 54.60 ft . to a calculated point for an angle corner of the herein described tract;
6.) S 05 deg. $1^{\prime}, 37^{\prime \prime}$ W 61.67 ft . to a calculated point for an angle corner of the herein described tract;
7.) S 84 deg. $4^{\prime} 2^{\prime \prime} \mathbf{\prime \prime} \mathrm{E} 64.43 \mathrm{ft}$. to a calculated point at a point of curvature;
8.) along a curve to the right with a radius of 4.00 ft . for an arc length of 5.40 ft . and which chord bears, $\mathbf{S} 46$ deg. $05^{\prime} 55^{\prime \prime} \mathbf{E} 5.00 \mathrm{ft}$. to a calculated point at a point of tangency;
9.) $\mathrm{S}^{\mathbf{S}} \mathbf{0 7}$ deg. $23^{\prime} 2^{\prime \prime}$ E 77.70 ft . to a calculated point at a point of curvature for the most Easterly Southeast corner of the herein described tract;
