Authorize award and execution of a contract through the State of Texas Procurement and Support Services Cooperative Purchasing Program (TEXAS MULTIPLE AWARD SCHEDULE (TXMAS), with OCE NORTH AMERICA, INC. Chicago, IL for the purchase and installation of a wide format printing system and maintenance service in an estimated amount not to exceed \$72,066.62.

Amount and Source of Funding

Funding in the amount of \$56,076.62 is available in the Fiscal Year 2011-2012 Operating Budget of the Public Works Department. Funding for the remaining maintenance support is contingent upon available funding in future operating budgets.

Additional Backup Information

This contract is for the purchase, installation and maintenance of a wide formatting printing system for the Engineering Services Division of the Public Works Department (ESD). As part of the proposal a three year maintenance agreement of the Oce Cool Wave 600 wide formatting printing system will be established for ESD on a separate agreement after a 90-day warranty expires. The maintenance plan includes 60,000 square feet annually, and 12 cartons of toner. Engineering Services prints wide format (24x 36) sets of plots (generally from 100 to up to 350 numbered pages) submitted and spooled through a server with plotting software that catalogs the set page order and numbers the pages, inserts/prints file location. Queues of plot sets are recorded and can be recalled or altered slightly, limiting the re-upload of "sets" page by page to a new queue. Once spooled, printing occurs consecutively. More than one plot set print request can be sent to the plot server for a queue of print jobs. The Oce Cool Wave 600 model has color capability, an onboard server/processor for spooking and the capacity for scanning. All three features are necessary for the size of the Engineering division. The Oce Color Wave 600 meets all Engineering Services Division business needs for scanning, printing, and handling multiple paper roll sizes.

The current machine leased from Xerox has exited the wide-format business and not longer makes comparable machines. Our current machine has frequent down time due to service issues and since Xerox has exited the wide-format business, replacement parts have limited availability we are loosing support form the manufacturer. An HP large format printer was compared and results were it is good for art printing, not engineering plot set management.

This cooperative purchasing established by the Texas Building and Procurement Commission, allows the City to use TXMAS contracts that have been developed from contracts that were competitively bid and awarded by the General Services Administration's Federal Supply service.
