 13 from water and single family use to recreation and open space use for the property  
 14 located at 5509-5609 Stuart Circle on the future land use map attached as Exhibit "A"  
 15 and incorporated in this ordinance, and described in File NPA-2011-0016.02 at the  
 16 Planning and Development Review Department.

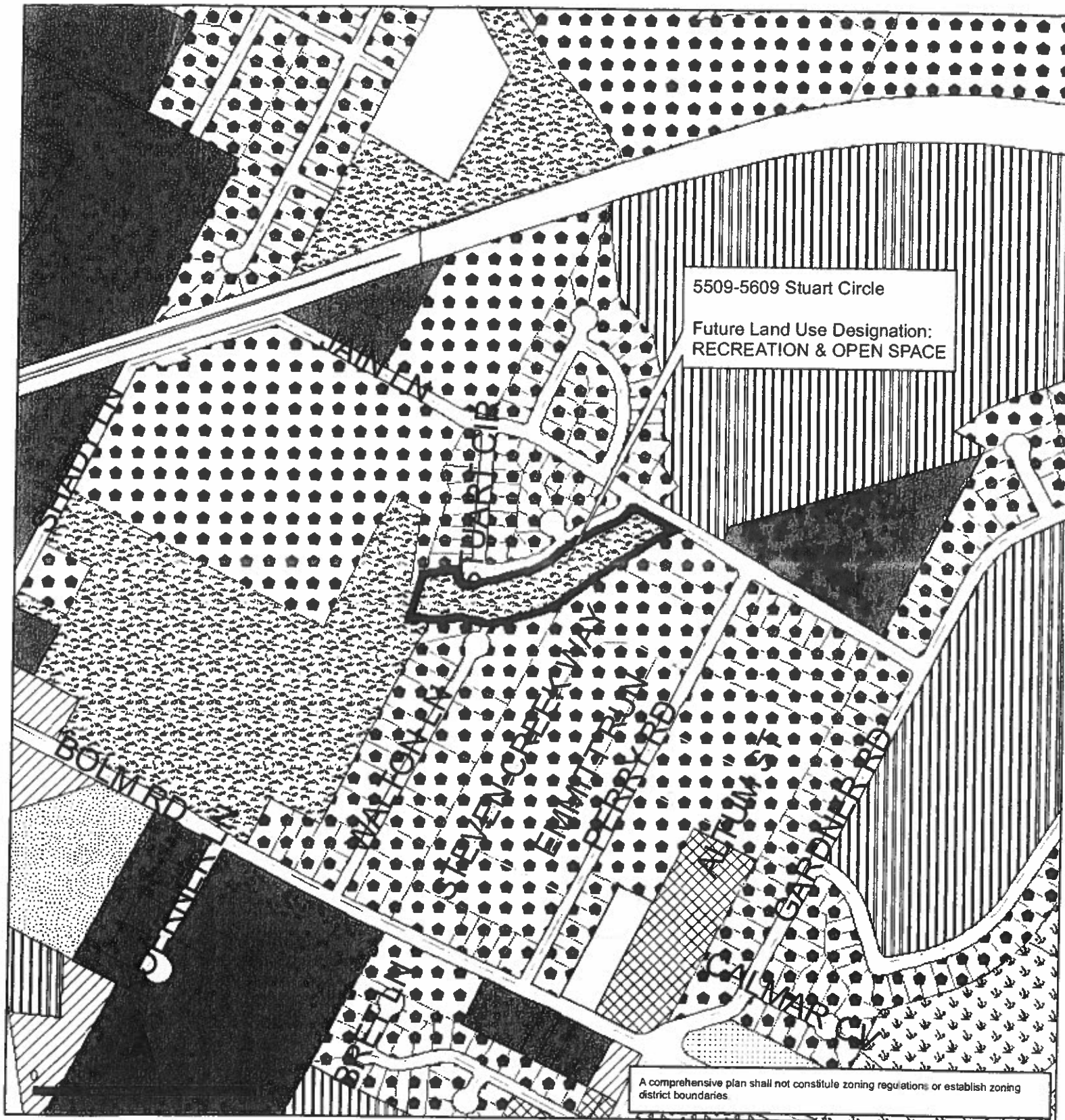
