PROPOSAL

Demolish a ca. 1936 house.

ARCHITECTURE

One-story irregular-plan, cross-gabled frame dwelling with a partial-width inset porch and single and paired 1:1 fenestration.

RESEARCH

The first owners and occupants of the house were William A. and Theo Butler, who moved here from 2906 Rio Grande Street. William A. Butler was an engineer for the Austin Ice Company and later for Capital Ice and Cold Storage. The Butlers lived here until around 1942. The next owners and occupants were Roy and Bertha Wray. Roy Wray was a carpenter, who served as the superintendent of construction on Bass Concert Hall at the University of Texas. Roy and Bertha Wray lived in the house until very recently. Roy Wray passed away July 3, 2011; Bertha Wray survives.


STAFF COMMENTS

The house is beyond the bounds of the Comprehensive Cultural Resources Survey (1984).

STAFF RECOMMENDATION

Release the demolition permit. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.
