## **ORDINANCE NO.**

AN ORDINANCE WAIVING CERTAIN FEES AND COSTS FOR THE 2012 AUSTIN FARMER'S MARKETS, A CITY CO-SPONSORED EVENT, DURING THE 2012 CALENDAR YEAR.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The 2012 Austin Farmer's Markets, a City co-sponsored event with the Sustainable Food Center, will be held at Republic Square Park and at the intersection of Triangle Avenue and 46<sup>th</sup> Street (bordering Triangle Park) on selected days during the 2012 calendar year. Food vendors for the 2012 Austin Farmer's Markets shall follow the guidelines and requirements of City Code Chapter 8-3 (Restrictions on Food, Beverage, and Containers) and Chapter 10-3 (Food and Food Handlers).

**PART 2.** Council waives the following fees and charges for the 2012 Austin Farmer's Markets. Fees that have been paid shall be reimbursed to the Sustainable Food Center.

Park Rental Fees (Triangle Park; \$150 x 52 weeks)	\$7,800

PART 3. Council waives the following fees and charges for booths that are sponsored and operated by the Sustainable Food Center at 2012 Austin Farmer's Markets.

Permits allocated for one farmer's market location may not be transferred to another market, and permits issued for a specific date may not be used on any other date. The permits may not be transferred to any party.
6 7 8 9	<b>PART 5.</b> The fee waivers under Part 3 of this Ordinance are intended to benefit only booths sponsored and operated by the Sustainable Food Center at the 2012 Austin Farmer's Markets. All other vendors operating booths at 2012 Austin Farmer's Markets must apply for and pay the fees for all permits required to operate their respective booths.
