Mayor McClellan called to order the Special Called Meeting of the Council for the purpose of canvassing the returns and adoption of Resolution declaring the results of the January 16, 1982 Special Municipal Election, at 10:03 A.M., noting the absence of Councilmembers' Duncan, Deuser, Mayor Pro Tem Trevino, Councilmembers Goodman and Urdy. Mayor McClellan announced business could not be conducted until a quorum was present. Councilmember Duncan entered the Council Chamber at 10:05; Councilmember Deuser at 10:20. Councilmember Goodman was absent due to illness. The Council Meeting began at 10:20 A.M.

Mayor McClellan asked if there were any irregularities in the election procedures. Mr. Barho, Judge, Central Counting Station, reported there were no irregularities, other than the usual few discrepancies in the sign-in sheets and transmittal. He said everything was on schedule.

The Council then proceeded to canvass the returns.and reported as follows:
