<p>Authorize award and execution of Amendment No. 5 to a contract with ADS, LLC, for Insta-Valve, Hydra-Stop fittings and cutters for the Austin Water Utility for repair work to the City's water distribution system, to extend the contract for one 12-month period in an estimated amount not to exceed \$20,000, for a revised total estimated amount not to exceed \$110,000.</p>

<p>Funding in the amount of \$15,000 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility. Funding for the remaining one month of the extension option is contingent upon available funding in future budgets.</p>

Additional Backup Information				

This contract provides for Inst-Valve, Hydra-Stop fittings and cutters for the Austin Water Utility. Austin Water Utility line crews use the fittings and cutters as needed to perform work in the City's water distribution system. The fittings and cutters can pressure tap lines in sizes ranging from 4" to 20" without interrupting service. These fittings and cutters are used with Hydra-Stop tapping equipment currently owned by the Austin Water Utility.

This contract was awarded as a sole source in 2007 for a 24-month base period in an amount of \$40,000 with three 12-month extension options. Amendment No. 1 exercised an administrative increase in the amount of \$10,000. Amendment Nos. 2 and 4 exercised the first and second extension options in the amount of \$20,000 each. This recommended Council action is to approve Amendment No. 5 for \$20,000 for the third and final 12-month extension option, for a final contract value of \$110,000.
