MINUTES

A. CALL TO ORDER

Chair Rivera called the meeting to order at 6:15 p.m.

B. APPROVAL OF MINUTES

Scott Johnson spoke to the Board regarding adding a donation line to the City of Austin Utility Bill to allow citizens to donate money that would directly benefit parks.

Norman Kittredge spoke to the Board regarding his unhappiness with the Intercare Corporation managing the public cemeteries.

6. Action Item Establish formal procedures

Board Member Perales made a motion adopting the establishment of formal procedures. Board Member Guerrero seconded the motion. The motion carried on a vote of 5-0.

7. Action Item Make a recommendation to the Director regarding 1404 Rockcliff Rd.

Board Member Osgood made a motion to approve the shoreline modification; a variance to the minimum set-back requirements; and granted a variance to the maximum length of a boat dock. Board Member Perales seconded the motion. The motion carried on a vote of 5-0.

8. Action Item Make a recommendation to City Council regarding the relocation of a transmission pole at Shoal Beach.

Board Member Lee made a motion approving the relocation of a transmission pole at Shoal Beach. Board Member Guerrero seconded the motion. The motion carried on a vote of 5-0.

9. Action Item Make a recommendation to City Council regarding AISD Drainage Improvements at Perry Park.

Board Member Lee made a motion approving the AISD drainage improvements at Perry Park. Board Member Guerrero seconded the motion. The motion carried on a vote of 5-0.

10. Action Item

Make a recommendation to the Director approving the Preferred Alternative from the Norwood Park Conditions Assessment and Feasibility Report as prepared by CasaBella Architects along with recommendation to enter into a Park Development Agreement with Norwood Park Foundation (Norwood Posse) toward the rehabilitation of the Norwood House.

Board Member Perales made a motion to amend and approve the recommendation to read, "Recommend to the Director the approval of the Preferred Alternative from the Norwood Park Conditions Assessment and Feasibility Report as prepared by Casabella Architects along with a recommendation to enter into a Park Development Agreement with the Norwood Park Foundation (Norwood Posse) toward the rehabilitation of the Norwood House and for the Director to receive funding through the next bond package and general fund appropriation for maintenance and operation of Norwood Park." Board Member Guerrero seconded the motion. The motion carried on a vote of 5-0.

11. Action Item Make a recommendation to Council and the Director approving the Design of the Boardwalk Trail at Lady Bird Lake.

Board Member Osgood made a motion approving the design of the Boardwalk Trail at Lady Bird Lake. Board Member Perales seconded the motion. The motion carried on a vote of 5-0.

12. Action Item Make a recommendation to Council approving the amendment to the Smoking in Public Places Ordinance by prohibiting smoking in parks.

Board Member Guerrero made a motion approving the amendment to the Smoking in Public Places Ordinance by prohibiting smoking in parks. Board Member Osgood seconded the motion. The motion carried on a vote of 4-1, with Board Member Lee voting against.

Action Item Approve the 2012 Parks and Recreation Board Meeting Schedule Board Member Lee made the motion to approve the 2012 Parks and Recreation Board Meeting Schedule, including moving the November meeting to November 20, 2012 and moving the December meeting to December 18, 2012. Board Member Osgood seconded the motion. The motion carried on a vote of 5-0.

F. DIRECTOR'S REPORT

Cemeteries Master Plan Update – a memo was sent to Board on the project's current status.

Hancock Golf Course – PARD has been working with the Austin Water Utility Department (AWU) to provide gray water to golf course. AWU will construct and assume all costs associated to the project. PARD will reimburse AWU by subtracting the amount owed, from future mitigation funds on AWU projects on parkland.

Waller Creek Boathouse – negotiations are on-going and the Department hopes to have a contract for the Board to review soon.

Stand-Up Paddle Rentals at Joe's Crab Shack – the proprietors' of this business were operating illegally by not having a concession permit. They also damaged parkland. The Director and the Assistant City Manager will be meeting with this group to discuss re-mediation of the parkland.

G. FUTURE ITEMS FROM BOARD MEMBERS

Board Member Guerrero asked for a member of the Mayor's Council on Disability to join the Joint Committee of the Environmental Board and the Parks and Recreation Board.

Board Member Lee asked for an update and an action plan on the water quality report for Bull Creek.
