### Subject

Authorize award and execution of two 24-month requirement supply contracts with ACT PIPE & SUPPLY in an amount not to exceed \$124,184, with two 12-month extension options in an amount not to exceed \$62,092 per extension option, for a total contract amount not to exceed \$248,368; and with HD SUPPLY WATER WORKS in an amount not to exceed \$351,314, with two 12-month extension options in an amount not to exceed \$175,657 per extension option, for a total contract amount not to exceed \$702,628, for ductile iron fittings for the Austin Water Utility to be used in water services installation and repair.

## Amount and Source of Funding

Funding in the amount of \$138,687 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility. Funding for the seventeen remaining months of the original contract period and extension options is contingent upon available funding in future budgets.

#### **PRICE ANALYSIS**

- a. Adequate competition.
- b. Two hundred twenty-four notices were sent, including five WBEs. There were no known MBEs. Four bids were received, with no response from the WBEs.
- c. The pricing offered represents an approximate 18% increase from the last contract award August 2008. This increase can be attributed to the rising costs in steel and other metals.

- a. Lowest bids received. Municipal Water Works and HD Supply Waterworks are the current providers.
- b. The Purchasing Office concurs with the Austin Water Utility's recommended award.
