AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 3010 HONEY TREE LANE, BUILDING B FROM PUBLIC (P) DISTRICT TO SINGLE FAMILY RESIDENCE LARGE LOT (SF-1) DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from public (P) district to single family residence large lot (SF-1) district on the property (the "Property") described in Zoning Case No. C14-2011-0140, on file at the Planning and Development Review Department, as follows:

A 0.0677 acre tract of land, more or less, out of the Henry P. Hill League No. 21 the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance;

A 0.2295 acre tract of land, more or less, out of the Henry P. Hill League No. 21 the tract of land being more particularly described by metes and bounds in Exhibit "B" incorporated into this ordinance; and,

A 0.0268 acre tract of land, more or less, out of the Henry P. Hill League No. 21 the tract of land being more particularly described by metes and bounds in Exhibit "C" incorporated into this ordinance,

locally known as 3010 Honey Tree Lane, Building B in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "D".
