MOTION: To retain existing tax exemption formula. (Rosato/Arriaga) Vote: 4-0.

City Code Section 25-2-352 (3) (b) (ii)

MOTION: Do not define "longstanding" with years. Leave to the discretion of the Historic Landmark Commission (Arriaga/Wolfenden). Vote: 4-0.

City Code Section 25-2-352 (3) (b) (iv)

MOTION: Leave the word "neighborhood" in the description of Community Value (Arriaga/Wolfenden). Vote: 4-0.

1. C14-2011-0065/C14H-1979-0019

Bosche-Hogg Building 804 Congress Avenue and

800 Congress Avenue (Congress Avenue Historic District)

Proposal: Zoning change from CBD (800 Congress Avenue) and CBD-H (804 Congress Avenue) to CBD-CURE and CBD-H-CURE.

Applicant: Gone to Texas Capital One, L.P.

City Staff: Clark Patterson, Planning and Development Review Department, 974-7691.

Staff Recommendation: Recommend CBD-CURE for 800 Congress Avenue and CBD-H-CURE zoning for 804 Congress Avenue.

Tom Ezell, David Kahn and Steve Drenner spoke in support. Barry Lewis, Tere O'Connell, Charles Betts and Jim Nix spoke in opposition. Steve Drenner spoke in rebuttal. The public hearing was closed. (Arriaga/Wolfenden) Vote: 4-0.

Discussion: Endorse the applicant's request for a zoning change from CBD-CURE to CBD-H-CURE. However, do not support the applicant's request for a variance to the overlay. Instead, support the 15 foot setback at the roofline of the historic structure.

Staff Recommendation: Approve the Certificate of Appropriateness with additional recommendations to change the horizontal window on the north elevation to a vertical double-hung window, square the farter ends on the addition to differentiate the addition from the existing house, repair rather than replace historic windows, and delegate approval of the replacement door to staff.
